Introduction

Be it known that Earl J. Braxton ("Braxton") has been involved in the design and development of various designs of portable toilets, sanitizing stations, comfort stations, and the like for decades. Braxton's present inventions appear to be the front runners in the field and they are embodied in a number of issued patents and currently pending patent applications owned by Braxton. Braxton owns all the intellectual property rights to the below listed patents, trademarks, trade secrets and domain names.

Braxton intends to license this technology to manufacturers for their own production. Due to the nature of its business, Braxton is fully aware of the importance of his intellectual property rights and is taking necessary steps to protect its new designs and developments in key markets. Infringement

We are not aware of any actual or threatened infringement of the intellectual property of Braxton by third parties, nor are there any claims that Braxton's technologies would infringe the intellectual property rights of any third parties.


